1) NAME OF THE TRUST :-

This Public Charitable Trust shall be designated and be known by the Name of THE SHOBHANA EDUCATION SOCIETY P.T.R.No. F/ 514 (Pune)

2) REGISTERED OFFICE OF THE TRUST :-

At present registered office of the trust is

3) PROPERTIES OF THE TRUST :-

The Schedule of the trust properties separately annexed.

4) VESTING OF THE TRUST PROPERTIES :-

The Trust properties in Schedule A & Schedule B and known as well unknown shall vest in the trustees for the time being and shall be administered and managed by them subject to and in conformity with the provisions of the Public Trust Act.

5) OBJECTS OF THE TRUST :-

- i) To establish and run various educational institutions in phases such as nursery schools, primary schools, middle schools, high schools, colleges (conventional stream as well as a new stream), engineering colleges (including all types of technical education), medical colleges (include all types of pathy, Paramedical courses, nursing course and various other course of medical), residential schools, computer training institutions, law colleges, agricultural schools & colleges, schools/colleges imparting education in environment, information technology, pharmacy, diploma and degrees in education (D.Ed. And B.Ed.), music, arts, management (include all types of management course of various streams), research and development institutions. The trust also wants to establish educational opportunities for deaf, dumb, physically handicapped.
- ii) Through the medium of the trust facilities be created to impart education in Marathi, Hindi, English, Urdu, Sanskrit, Gujarati etc. for that purpose establish various school, colleges and other educational institution and also establish a Research and Development Institution for these educational activities. Start coaching class for the improvement in quality of education.
- iii) To construct hostels, residential homes, boarding arrangements, schools for the backward students, tribal and economically backward students and to arrange educational scholarships to those deserving students. To distribute books, notebooks and other study material to the needy students.
- iv) To organize through expert teachers classes for improvement in the educational standard, quality and content of education, establish libraries, arrange for the sports grounds and other facilities, to organize classes for M.P.S.C. U.P.S.C., N.T.S. Entrance examination for Navodaya Vidyalaya, Middle school and High school scholarship examination. Along with the educational development of the students, to extend guidance to the students, to nourish their hobbies and to bring out the hidden talents. To organize sports coaching from the expert and reputed sportsmen, also organize sports events; establish well equipped gymnasiums, yoga classes, establish research center for Yoga and nature therapy. Establish Sport Stadium for various types of sport. For this purpose lectures series would be organized from eminent authorities in this line.
- v) To develop small duration courses which will be complementary to the small scale industrial services sector e.g. technical, electrical, engineering, craft, tailoring, photography, painting etc. fashion designing, interior decoration, information technology, food processing etc. To start training centers for poultry, sheep and goat rearing, fishery, dairy, piggery, and Montessori courses.

- vi) To protect and enrich the Indian cultural heritage organize cultural programmes, debating competitions; essay competitions, handicrafts, drama competitions, and to arrange for the dissemination of knowledge bring out daily, weekly, monthly, booklets, and to arrange awakening of the society as such.
- vii) To successfully, undertake and pursue various activities which will be complimentary to the principal objectives and also within the established legal framework.

6) NUMBER OF TRUSTEES :-

The Number of trustees shall not less than three and more than seven. Surviving trustees may appoint more four trustees for period of three year if necessary. In event of the number of trustees falling below the minimum the existing trustee will act for appointing additional trustee/s. The office Bearer is life time trustee of the said trust and bear office for life time.

7) FIRST BOARD OF TRUSTEES :-

The following persons shall be the first Board of Trustees of the said Trust.

10) VESTING OF PROPERTY IN NEW TRUSTEES :-

So often as any new trustee or trustees shall be appointed as aforesaid the trust properties which for the time being are vested in the surviving or continuing trustees shall with all convenient dispatched the conveyed assigned or transferred so effectually vested in such new trustee or trustees either solely or jointly with surviving or continuing trustee/trustees as the same may require.

1) President -

- To preside over and conduct the meetings of the Board of trustees.
- To convene the all meetings of the Board of trustees.
- To decide all matters /issues by majority of votes.
- To take such action or to suggest such proposal which he deems fit and proper in the interest of the trust.
- The right to call any meeting.
- To operate joint account of society with secretary .
- To keep control over the staff of the trust.
- President shall have a casting vote in case of tie.

2) Vice- President -

- To perform the duties of the President in his absent.
- To work as per direction of the President.
